REQUEST TO CORRECT

The purpose of this form is to collect relevant information in relation to a Request to Correct that a United States resident in California, Colorado, Virginia, Utah and Connecticut (“United States resident”) or an authorized agent submits to Cummins in connection with exercising data privacy rights under the Disclosures for Individuals in the United States section of our Privacy Policy. The information that you provide will only be used for purposes of verifying your identity and processing your request, and not for unrelated purposes.

Once submitted, you will receive an email (at the address you provided), confirming that Cummins has received and is processing your request. You will also receive additional notification in relation to whether we were able to fulfill your request.

As part of the Request to Correct, Cummins will also notify its service providers and contractors to correct from their records your personal information, unless there are grounds for declining the request under the law. Cummins processes correction requests within 45 calendar days of receipt. In the rare event that we require additional time, we will contact you and let you know the reason why we require additional time. If so, your request will be processed no later than 90 calendar days from receipt.

Please note that the Right to Correct is not absolute and there may be certain legal reasons why we cannot process your request. If we deny your request, we will inform you of the reason and give you an opportunity to appeal.
