## Introduction

This document serves as a guideline to the manner in which Meritor receives Invoices via Electronic Data Interchange (EDI).

The Invoice (INVOIC) is used by Meritor to replace the paper based Invoice which is traditionally received from the supplier (whether by email, fax or post).

The Invoice message is based on (and fully compliant with) the following EDIFACT message:

Message: INVOIC  
Version : D.96A

The INVOIC message is a message claiming payment for goods or services supplied under conditions agreed between the seller and the buyer. The United Nations Standard Invoice Message, with correct data qualification, serves also as the specification for Debit Note and Credit Note messages. Throughout this document, the reference to 'Invoice' may be interpreted as conveying the wider meaning of 'Invoice/Credit Note/Debit Note'.

### Conventions

Where possible unused elements have been omitted. Only unused elements nested between used elements are included.

### Communication Details

In order for Meritor to transmit documents to hundreds of Suppliers, we have chosen the VAN services of IBM third party network. Please contact [meritor\\_support@us.ibm.com](mailto:meritor_support@us.ibm.com) for communication testing.

This does not mean that you must sign up with these networks in order to communicate with us. Ask your network provider how to pass data through (Interconnect vs. direct connect) to GXS network – our preferred VAN.

### Testing and Certification

Each new transaction set will require testing and certification by our EDI support staff. Once the transaction set has been certified, we will make arrangements with your EDI staff to begin transmission of data using the newly tested transaction set.
