Other	any institution, body or agency of the European Union competent to collect information on violations falling within the scope of the directive of 23 October 2019.

If, after having raised your concern with a Competent Authority as described above, no appropriate measures have been taken in response within three months of acknowledgment of receipt of your report (which can be extended by the authority to six months in certain circumstances), you can disclose your concerns to the public. However, in the case of a serious and imminent danger or if referring the concern to one of the Competent Authorities would put you at risk of retaliation, or would not enable the subject of the disclosure to be effectively remedied, due to the particular circumstances of the case (e.g. if evidence may be concealed or destroyed, or if you have serious grounds for believing that the authority may be in a conflict of interest, in collusion with the person making the report, or implicated in it) the concern may be raised directly with the public.
