# Total Sales at Cummins India Limited for Q1 up 39%, PBT up 28% 200% dividend confirmed

#### Pune: July 26, 2007

The Board of Directors of Cummins India Limited (CIL) in a meeting held today took on record the un-audited annual financial results for the quarter ended June 30, 2007. The Company announced a 39% increase in net sales to Rs 5,423 million in the same period last year. At the Annual General Meeting held today, the shareholders approved a 200% dividend including the 100% interim dividend announced in January this year.

Net sales for the quarter ending June 30, 2007 were Rs. 5,423 million, an increase of 39% over the same period last year, which had stood at Rs. 3,914 million. The net profit before tax for the quarter rose by 28% to Rs. 893 million compared to Rs. 699 million in the same period last year.

Anant Talaulicar, Chairman & Managing Director, Cummins India Limited said, "The Company has achieved robust growth in revenues this quarter. Our sales performance this quarter was strong across domestic power generation, industrial and automotive segments; as well as exports. As expected, the bottom line has come under pressure due to the significant appreciation of the Rupee in recent times. Our exports currently constitute approximately 30% of our total sales. We were able to offset some of this adverse impact with foreign exchange management policies, as well as continuing to drive efficiencies in our operations with the use of Six Sigma as well as partnering with suppliers on value engineering and productivity enhancing initiatives."
